### **Board Minutes--March 19, 2010**

*President Marcia called the meeting to order @ 6:00pm.*

*Minutes were approved.*

*Marcia announced that the 25<sup>th</sup> Anniversary plans are underway. The Nature Festival flyer is on Facebook and was sent to the schools. We have calendar decisions to make regarding workdays and meeting days.*

#### Treasurer's Report

*Total Assets: \$45,151.15   Everbank MMkt \$38,918.57 & Cking/M Mkt \$6,232.58*

*2011/2012 Budget was reviewed and showed that we were \$2,593.67 off 2011. This amount was due to the Green Flash. The Green Flash is included in the 2012 budget. Budget was approved.*

#### Park Manager

*Bob reported that due to staff shortage the following people have been assigned to various duties: Wendell (CSO), Bruce (Volunteers), and Bob (Volunteer Hours). Bob also mentioned that the State may provide money for another Club Cart and asked if the Friends would provide matching funds.*

*Motion passed that they Friends would provide matching fund for another Club Cart if the State offers to buy one for the Park. Bob asked for funds to pay for food expenses for the Park Volunteers picnic. Board approved this request and directed Bob to use the debit card.*

#### Membership Report

*Grand Total 99 members: 4 Artists; 2 Corporate; 53 Family; 38 Individual; 2 Patrons   Ten new members have joined since January 1.*

*Reminder renewal letters were sent out to 35 members last week.*

#### Yoga on the Beach

Michele Gerlach is catering and will have two assistants to serve. Michele is donating her time. Thank you Michele. Hot and cold hors d'orves will be served along with cake, wine, beer, coffee and water. Vivian Shea is in charge of decorations. Alliene Liden is handling our history books. We will have a membership table & slide show of the proposed boardwalk. Expenses to-date: \$130/paper goods and \$217/silver bracelets. There will be a committee meeting tomorrow @ 5PM in the CSO room.*

*Marcia said that Nature Festival needs to be reviewed as soon after this year's Festival is over. Marcia will contact the Moore's and set up a date (maybe April 18). At the review session, we will discuss changes and a new direction for this educational family festival.*

Larry and others will work to prepare a trailhead for the Boardwalk for the 25<sup>th</sup> Anniversary Celebration. Larry and Sharon are also working on the next copy of the PTP.*

*Brittany Petit will offer a Native Plant Workshop on Wednesday, March 21 @ 9AM; meet in the CSO room. The group will add more color to Delores's garden.*

*Kathryn, Marcia & Ann met with Suzanne Lennon of Paradise Advertising on March 14<sup>th</sup> to discuss a new logo for the Friends. The company will present to the Board their ideas at the April Board meeting.*

*Marcia directed our attention to the Strategic Plan prepared by Elaine McLaughlin. Discussion followed asking the Board to please read and to correct any information that we think is not exactly correct and to report changes to Marcia.*

*New Business*

*Larry told the Board that Lois Cantwell is presently our Ex-Officio Board Member but because she has relocated she has decided to not join the Friends this year. The Board moved to suspend her Ex-Officio position until she tells us that she wishes to rejoin our organization. Motion passed.*
